- 2. The SQURTS submittal form must be completed on-line a minimum of two weeks prior to the test week. To request a test, work with your site sponsor to make an online submittal at the web site below. The submittal form must include the required catalog literature, test type and levels, specific mounting & wiring details, and any product or test specific requirements. The on-line web address for the form is http://www.squrts.org/submittal.asp. On the calendar, the cut-off date for receipt of submittal forms is colored red and outlined. Submittal forms received after this date will be scheduled in the next SQURTS test week.
- 3. Members are responsible for supplying the test samples and they must arrive at Curtiss-Wright Nuclear a minimum of one week prior to the test week at the addresses below.
