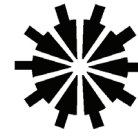

EPRI SQRSTS TESTING SCHEDULE

1. The 2022 SQRSTS test weeks are colored green on the calendar. The EPRI SQRSTS Test List and several useful links can be found at www.sqrsts.org.
2. The SQRSTS submittal form must be completed on-line a minimum of two weeks prior to the test week. To request a test, work with your site sponsor to make an online submittal at the web site below. The submittal form must include the required catalog literature, test type and levels, specific mounting & wiring details, and any product or test specific requirements. The on-line web address for the form is <http://www.sqrsts.org/submittal.asp>. On the calendar, the cut-off date for receipt of submittal forms is colored red and outlined. Submittal forms received after this date will be scheduled in the next SQRSTS test week.
3. Members are responsible for supplying the test samples and they must arrive at Curtiss-Wright Nuclear a minimum of one week prior to the test week at the addresses below. Alternatively, Curtiss-Wright Nuclear may be contracted to procure and prepare the test sample on behalf of the test member. Inquiries for these services should be directed to Adrienne Myers.
